Country of registration of vehicle for 2nd generation tachographs

(menu: Preview window of data from the digital tachograph / smart tachograph -> General and technical data)

- the field with the country of registration of vehicle was hidden for smart tachographs

Adding a driver automatically

(menu: Data -> Import data from file)

- adding a driver automatically during **Import data from file** was introduced

Overview of the number of infringements according to the level of seriousness

(menu: Reports -> Infringements and manipulations)

- an overview with the number of infringements according to the level of seriousness was added under the infringement list and at the end of infringement report

Format of reports

(menu: Reports)

- generating reports in PDF/A format was introduced

Exceptions for the quarantine time

(menu: Reports -> Infringements and manipulations)

- for the period between March 18, 2020 and April 16, 2020 a temporary relaxation of drivers' hours rules - Article 14(2) of Regulation (EC) No 561/2006 was added due to the quarantine time

GNSS Location - Expert license

(menu: Reports -> GNSS Location)

- Compare driving time and distance on the map was made available for Expert License as **GNSS location** in order to display locations from Generation 2 tachographs

Logging in integrated with Windows - Sweden




(menu: Logging into the program)

- a possibility of logging into the program using the button **Integrated login** was introduced

Version 6.0.0

Control's main window

menu: "Current control" tab

- the table with the lacks of records () was moved to the place next to the drivers' infringements
- the list with the active vehicles was added in the control's main window with  and  icons that allow displaying weekly and monthly charts for a chosen vehicle

New options in the program settings

menu: Settings -> Program settings

- **Show controlled period on reports** option which allows to display the controlled period on reports was added
- **automatically generate infringements after new readings have been loaded** option which allows to generate infringements after saving files was added
- **Save digital files in control folder** option which allows saving digital files in the control's directories
- **Show summary before saving the data from digital downloads** option was added; when it is checked, the window with a possibility of choosing files to save while importing data will be displayed

New options in analysis settings

menu: Settings -> Analysis settings -> Analysis

- **Require driver's preparation to work for at least 1 minutes after daily/weekly rest** was added
- **Working time of at most 6h without a break exceeded** option was divided into **break required within first 6h of work** and **break required within daily driving time**
- **Treat driving OUT as "other work"** option was changed into **Treat driving OUT recorded by driver as "other work"**
- **Treat driving OUT marked by user as "other work"** option was added
- a possibility of choosing the type of drivers' employment who will be checked while analyzing the infringements was added in Show transgressions section

- a possibility of setting night shift hours for a chosen type of carriage was added
- **No 15-min. break in each 6-hour-long work period** option was added

roadside check - Sweden

menu: Control -> New control

- roadside check is not available for Sweden

control on the premises - Sweden

menu: Control -> New control

- **control on the premises** was divided into:
 - driving time and rest periods control
 - work time control

Roadside Check Form - Sweden

menu: Reports -> Roadside Check Form

- Roadside Check Form is not available for Sweden

Statistical report - Sweden

menu: Controls menu

- **Statistical report STA**, which includes statistics for open controls, was added in Controls menu,

Report of altered activities

menu: Reports -> Additional reports -> Report of altered activities

- **Report of altered activities** was added

Summary report of infringements - Sweden

menu: Infringements and manipulations

- **Summary report of infregiments** was added

Driver's data in detail - Sweden

menu: Control -> Edit/view selected control

- **Driver's data in detail report** was added


Vehicle control according to discs

menu: Reports -> Additional reports -> Vehicle control

- changes in columns of the detailed, synthetic and real dates reports were introduced

Adding notes - Sweden

menu: Toolbar

- a button  which allows to create notes for the entire control was added in the program's menu

Record sheet view

menu: Record sheet view/edit window -> Read preview

- a possibility of zooming in and out the record sheet view with buttons: , ,  was added

menu: Record sheet view/edit window

- a possibility of adding end location and start location was added

Displaying the back side of the record sheet - Sweden

menu: Record sheet view/edit window -> Read preview

- a possibility of displaying the back side of the record sheet was added

Daily chart, Weekly chart and Monthly chart

menu: View/edit a day from a driver card window -> Preview and data edition

- a function of adding activities with a possibility of defining specific time on the daily chart

menu: Reports -> Weekly chart and Monthly chart

- after hovering the mouse over an activity on the weekly and monthly charts, information concerning the source of the activity (record sheet or digital file) is displayed

menu: View/edit a day from a driver card window -> Preview and data edition and menu: Reports -> Weekly chart and Monthly chart

- on the daily, weekly and monthly charts a possibility of adding periods in which a car/driver drives according to AETR agreement was added
- under the daily chart and in **Overview** tab next to weekly and monthly charts, the tables containing OUT and AETR driving periods were added

menu: Reports -> Weekly chart

- on the weekly chart next to the date, the icons  and  that inform about absences and sick leaves were added

AETR periods


menu: Reports -> Weekly chart i Monthly chart

- marking AETR periods on weekly and monthly charts [] was introduced

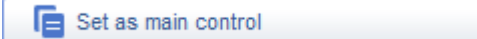
Copy of a control

menu: Current control

- on the Current control page, an option of making a copy of the control


 was added

- a possibility of setting the copy as **main control** was added



Setting the control as complete

menu: Toolbar

- a button  which allows to set the control as complete was added

Confidential data

menu: Control -> New control

- **Mark all drivers data as confidential (in reports)** option, which allows to hide personal data on the reports, was added

Driver's average weekly working time report - detailed

menu: Reports -> Infringements and manipulations -> Detailed report

- displaying absences in **Other work time** column was added

Lack of driver's and vehicle's records

menu: Reports -> Lack of driver's and vehicle's records

- an option of displaying lacks longer or shorter than a chosen period of time was added
- an option of showing manual rests longer or shorter than a chosen period of time was added

Control data - Sweden

menu: Control -> New control

- **Download control data** option which allows to download data from Storage System was added in the window of creating a new control

menu: Current control

- a button **Synchronize control data**, which allows to synchronize data with Storage System, was added in Current control window

Type of employment

menu: Driver -> Add and Edit

- a possibility of choosing the type of employment was added in the windows of adding and editing drivers

menu: Reports -> Infringements and manipulations / Control report

- the infringements out of the employment period are hidden on the infringements list and control report

menu: Reports -> Infringements and manipulations

- displaying the type of employment on the infringements list next to the every infringement of "working time" was added

Absence

menu: Driver -> Add i Edit

- a possibility of adding periods of absence was added in the adding a new driver and editing a driver windows

Reports - Sweden

menu: Reports

- the same template was applied to all of the reports

Infringements and manipulations - Sweden

menu: Reports -> Infringements and manipulations

- columns with legal basis and number of the infringement was added
- columns **No** and **ferry** were deleted
- new types of infringements were added
- status **New** was added on the infringement list in **Infringement** column

- on the bar under the infringement list, three fields were added: **amount of infringements counted from tariff**, **amount reduce** and **final sum**
- a possibility of adding, modifying and deleting infringements for users with certain permissions was added

Data analysis according to a chosen control type - Sweden

menu: Reports -> Infringements and manipulations

- for driving time control, infringements of work time are not analyzed
- for work time control, infringements of work time are analyzed

Infringements and manipulations

menu: Reports -> Infringements and manipulations

- a possibility of choosing the drivers for whom infringements will be generated

Infringements - Switzerland

menu: Reports -> Infringements and manipulations

- a new type of infringement after 5,5 h of work for the analysis according to ARV2 was introduced
- a new type of infringement after 6h of work for the analysis according to ARV1

Driver

menu: Driver -> Edit and Driver -> Add

- **Analysis options** section, which was previously in Infringements and manipulations window, was added in the adding a new driver and editing a driver windows
- *menu: Driver -> Add -> Analysis options*
- a possibility of adding periods in which an exception is applied for **allow weekly rest periods after up to 12 days (art. 29 reg. 1073/2009)**

Import data from file

menu: Data -> Import data from file

- **Import data from file** option, which allows to import activities from the file to the program, was added

User's permissions - Sweden

menu: User -> Add

- a possibility of choosing permission level was added in the adding a new user and editing a user windows

Vehicle control according to discs - detailed (analytical)

menu: Reports -> Additional reports -> Vehicle control

- start location and end location were added

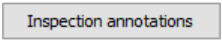
Digital tachograph data

menu: Data -> Digital tachograph data

- a possibility of editing fields **Tachograph malfunctioning since** and **Next calibration date** was added

Including notes on the infringements and manipulations report

menu: Reports -> Infringements and manipulations

- there were added two options: **Attach notes on violations** and **Attach control notes** in the window of generating the report
- a possibility of operating the program while the form of editing annotations, which you can find in the infringement tab, is open ()

Control exporting - France

menu: Control -> Export selected controls

- the options of the control's export were changed into **Exporter vers TachoScan Control Administrateur et vers Greco**

Registration nation

menu: Vehicle -> Add / Edit

- a possibility of choosing vehicle's registration nation was added in adding a vehicle and editing a vehicle windows

New language version of the program

- Swedish language version was introduced

(menu: Settings -> Program settings)

- a possibility of choosing the Swedish language was added (**Select program language and tariff**)

Swedish tariff

- Swedish tariff was added


Validation of case number - Sweden

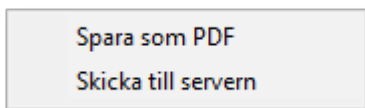
menu: Control -> New control
